As the new Chairman of NMS, I must first reflect on the immense contribution of David Jones, my predecessor, for the last 11 years. He has ensured our success in almost every way, including the creation of a number of bursary schemes, and the Fishmongers' Faraday award. On behalf of the whole NMS community, I would like to thank him for all that he has done for this organisation, and I am pleased to say that he has agreed to remain as a director. While on the subject of directors, I would also like to welcome Rajinder Funnell to our board. Raj has a background in publishing, teaching, and fundraising, and is particularly interested in supporting all our safeguarding initiatives.

In January 2022 Claire Murdoch, previously Head teacher at Faraday, became Head teacher at Maple Walk and Lucas Motion, previously Deputy Head teacher at Maple Walk became Head teacher at Faraday. They have made a tremendous start, and the extraordinary difficulties of running schools during a pandemic and lockdown now thankfully seem a distant memory. The leavers' results have, as with previous years remained outstanding with an impressive percentage winning awards across a range of academic, artistic, and sporting areas.

The Independent Schools Inspectorate (ISI) rated Faraday excellent in all areas in its November 2022 report. This means that both our schools now have the highest available rating from ISI, a testament to all that has been achieved in offering outstanding education based on good governance, sound finance, and the hard work of all those involved, including, of course, our teachers, and head office staff. It is worth noting that we have achieved all this while consistently charging fees which are lower than 90% of other independent schools in London.

Everyone involved with NMS is proud of our schools, and if the Chairman's message was to leave you with one thought, it would be this: please come and visit our schools to see for yourself.

We also welcomed two Ukrainian children to Maple Walk in March who will remain as pupils for as long as is needed.



My previous two years' reviews have been dominated by the effect the pandemic has had on our running of the schools and the challenges this presented us with, both operationally and financially. So, it was a relief when all restrictions were lifted on educational establishments in April.

Reflecting on this year, it could best be described as a transitional period, both in terms of moving away from Covid restrictions and with the change of Heads at both schools in January.

We spent the first six months with the now familiar testing routines, sporadic cases of Covid and at times, outbreaks at both schools. Our staff, although severely impacted by either their own illness or the need to cover for colleagues, carried on stoically, for which I cannot thank them enough. However the impact on our finances was significant, costs for agency staff cover in an increasingly tight labour market were significantly above budget.

We bade farewell to Sarah Gillam, Head of Maple Walk, in December and in January Claire Murdoch arrived having spent three years as Head of Faraday, Lucas Motion, previously Maple Walk Deputy Head, took over at Faraday. The fact that they know each other's schools so well has been of great benefit to both them and the schools, in smoothing this transition, which is never easy. They have been mutually supportive and the staff at the two schools are also working more closely together sharing ideas and resources, injecting new energy into the schools. It has been a real pleasure to spend regular time at the schools again and see a full calendar of activities.

We also welcomed two Ukrainian children to Maple Walk in March who will remain as pupils for as long as is needed

This year we report a post tax loss of £68,000. Whilst disappointing, the fact that we have weathered nearly three years of Covid upheaval and only incurred a loss in one year is somewhat reassuring. We continue to review our costs but with the backdrop of rising inflation and a competitive labour market, the balancing act of keeping fees affordable and our staff fairly compensated, is an ongoing challenge. Looking to the future, we are encouraged by increased numbers starting at the schools in September 2022 and beyond. As always we are grateful to our supporters and Patrons and those who have generously provided bursary funds.

I was lucky enough to have a fantastic handover with Sarah Gillam, during her last term at Maple Walk, where I learnt more about the vibrant community and all those who make it the place it is. Getting to know the children, staff and parents was an important part allowing us to start the New Year in 2022 with such energy, enthusiasm and insight.

Since taking the reins in the spring term, I have seen our sports department flourish with an inspirational team encouraging children to take part in all sports, both competitive and non-competitive with many successes in local and national competitions. I would like to thank the Friends of Maple Walk for all their fundraising and support this year; they are a key part of what makes Maple Walk such a special, dynamic and innovative school. With their help, it looks to be an exciting year ahead!

The new year saw the end of Covid-19 restrictions and a welcome return to normal across the school, enabling Faraday's strengths in community, collaboration and creativity to flourish once more. Visitors have returned to site to see for themselves all that the school has to offer. Staff continue to develop the curriculum with a sense of renewed momentum.
